Hinckley Allen served as bond counsel to Mass Development in connection with a \$400 million financing of the Beth Israel Lahey Obligated Group, which consists of 9 hospitals and 5 additional affiliates. The bonds financed the costs of a wide range of acquisition, construction, and expansion of the Obligated Group's facilities, as well as the acquisition and implementation of electronic medical record and information systems.



Hinckley Allen represented the International Tennis Hall of Fame (ITHF) in the successful negotiation of the sale of its Association of Tennis Professionals (ATP) tournament, currently known as the Infosys Hall of Fame Open. The sale coincides with a broader drive by the ATP Tour to enhance its overall tournament calendar and marks the beginning of ITHF's process of reimagining professional tennis in Newport, Rhode Island, with the expectation that beginning in 2025 a new era of pro tennis on ITHF's historic courts will begin.



Hinckley Allen represented its long-term client NRG, a professional gaming and entertainment company headquartered in Los Angeles, in its acquisition of the 'League of Legends' esports team and related assets from Madison Square Garden Sports Corp. MSG Sports also obtained a significant equity interest in NRG as part of the transaction. NRG operates a stable of leading esports teams across a number of games, as well as a leading entertainment business generating followers on NRG's content channels as well as under its social gaming brand, Full Squad Gaming.
